KOTA KINABALU: Universiti Malaysia Sabah's (UMS) plans to build an eco-friendly Cultural Resort Village on 40 to 50 acres of beach land to train its hospitality students beyond the classroom.

He also said that UMS hoped to reduce its future electricity bill between 20 to 30 per

cent by using alternative energy.
